Library Programs of the Year

2010 Awards, Presented on May 16, 2011 by the Southern Adirondack Library System at its 53rd Annual Meeting

Saratoga Springs Public Library for *Video Game Design Lab for Teens*: Created by Teen Services Librarian, Trevor Oakley, this program enhances services to teens by weaving literacy, creativity, technology, and career preparation into one fun and innovative package. Launched in the Spring of 2010, the program is now a monthly offering. At each session, attendees are introduced to a new game creation software product. The software must be free to use or try, require no programming or coding knowledge to operate, and be available for all users to download at home or use in the library. The program focuses on teaching teens how to think like a game designer, introducing them to different aspects of game creation such as Literacy and Fine Arts. Attendees start with a design document which tells the story with rewards/punishments and goals. Designers are also artists and musicians, creating a variety of sound effects and scores which help to shape the mood of the game, which also helps to tell the story set in the design document.

Town of Ballston Community Library for *Camp Half Blood Overnight Event*: At Camp Half Blood, Middle School students spent the night at the library and immersed themselves in Greek Mythology and the World of Percy Jackson. Each participant was sorted into a cabin based upon a Greek god, and all library staff members dressed in costume. The cabins competed in a laser tag tournament, a Percy Jackson Trivia contest and Wii games. They learned to write their names using Greek characters, sculpted with clay and created camp membership necklaces. Greek laurels were made, and a temple for Athena was built from blocks. Donations from the Friends of the Library, Pizza Works in Burnt Hills, Girl Scout Troop #165 and volunteers helped make this event a success. Staff and teens are looking forward to the next overnight event.

TAKING STOCK: Minimum Standards

Regulations of the Commissioner of Education

Regulation 90.2: Standards for Registration of Public, Free Association and Indian Libraries

- (a) A public, free association or Indian library will be registered if it meets the following standards satisfactory to the commissioner:
- (1) is governed by written bylaws which outline the responsibilities and procedures of the library board of trustees;
- (2) has a board-approved, written long-range plan of service;
- (3) presents an annual report to the community on the library's progress in meeting its goals and objectives;
- (4) has board-approved written policies for the operation of the library;
- (5) presents annually to appropriate funding agencies a written budget which would enable the library to meet or exceed these standards and to carry out its long-range plan of service;
- (6) periodically evaluates the effectiveness of the library's collection and services in meeting community needs;
- (7) is open the following scheduled hours (see chart)
- (8) maintains a facility to meet community needs, including adequate space, lighting, shelving, seating, and restroom;
- (9) has a telephone, photocopier, microcomputer, printer, telefacsimile machine and other equipment necessary to facilitate access to information;
- (10) distributes printed information listing the library's hours open, borrowing rules, services, location and phone number.
- (11) employs a paid director in accordance with the provisions of Section 90.8 of this Part (see chart)
- (b) Any public, free association or Indian library registered by the department at the time this section takes effect shall be required to meet the standards for registration in subdivision (a) of this section on the following schedule:
- (1) meet the standards of paragraphs (1) through (5) and (10) of subdivision (a) of this section on or before January 1, 1995.

- (2) meet the standards of paragraph (6) of subdivision (a) of this section on or before January 1, 1997.
- (3) meet the standards of paragraphs (7), (8), (9) and (11) of subdivision (a) of this section on or before January 1, 1999.
- (c) Variances. If circumstances over which any public, free association or Indian library has no control prevent it from meeting one or more of the standards of service set forward in subdivision (a) of this section, such library may apply for a variance for such standard(s). The application for such variance shall be submitted for such library by the public library system of which such library is a member, in a form prescribed by the commissioner. No variance granted pursuant to this subdivision shall be deemed to relieve a public, free association or Indian library of any obligation imposed by any other provision of federal or state law.



Federal Library Services and Technology Act (LSTA) Grants (FY2010-2012)

Continuing Education for Library Managers (\$11,400 in 2010) This project was to provide a series of Continuing Education workshops designed for library staff and trustees. The objective of the workshops was to give the attendees the skills and knowledge needed in order to best work with the many diverse groups of people who are using their libraries daily. The workshops covered the topics of mental illness, stress management & coping skills, library safety & security, and understanding/interpreting the U.S. Census. The Mental Health Workshop was presented by the CDPC Mental Health Players on May 19, 2010. Stress Management & Coping Skills was presented by Patricia O'Gorman four times regionally in June 2010. Polly-Alida Farrington presented Census & Community: Developing a Community Profile on September 14, 2010. Library Safety & Security was presented by Bryan Oliver on October 27 & 28, 2010. A total of 164 people

attended the programs.

Summer Reading Program (\$6,000 in 2010)

This program provides libraries a grant for programs and materials to support their Summer Reading Programs.





Although funding from New York State remained on the decline in 2010 our 52nd year as Central Library to the Southern Adirondack Library System, Central Library services continued in using state and local funds. Crandall Public Library still provides the foundation upon which other libraries in the system base their out-of-system interlibrary loans, sophisticated reference assistance – above and beyond Google – and access to a growing body of electronic resources. During 2010 the Crandall Public Library's underpinning of vibrant, effective and efficient services experienced another year of increased use. This continuing success could not have been accomplished without the guidance and support of the Southern Adirondack Library System, its Board of Trustees, Director, Sara Dallas and staff. We also extend our appreciation to the trustees of Crandall Public Library and the trustees of SALS who approve the Central Library Plan of Service each year. Implementation of the Central Library Plan of Service would also not be possible without the dedication of Crandall staff, and the 34 member libraries that use the services of the Central Library.

As recipients of Central Library services, member libraries and their customers provide assessment of the effectiveness of our services and their reactions inform the Central Library program. People have access to job skills and job readiness training through our Public Computer Center funded through the New York State Library as a conduit for the American Reinvestment and Recovery Act (ARRA) and Broadband Technology Opportunities Program (BTOP). Crandall Public Library's participation in NYLA's Snap-ShotNY, a one-day glimpse at library services also reinforced this need to offer all kinds of career information. One Central Library customer stated:

library has expedited my claim information via internet access and had helped provide entertainment through loaned books and DVDs while my income has been reduced. I have also accessed information I am using to help me in my rehabilitation efforts.

Crandall Public Library programs and services continued to expand in 2010. For example:

- Provided 33,149 items for Central Library Interlibrary loan. This averages about 100 items loaned for every day we were open!
- CLDA funds are for the improvement of the Central Library's function as a major reference, information, interlibrary loan and electronic resource in the system. With CBA funds, Crandall Public Library continued to purchase non-fiction digital books (both audio and ebooks) for the OverDrive "virtual branch." Overall in 2010 there were 17,238 check-outs a 116% increase over the number of checkouts in 2009.
- Continued to add to Crandall's in-depth adult, non-fiction collections to supplement services to the 30.8% of Crandall customers who are Central Library patrons.
 Central library staff is always willing to share their expertise with member libraries and provide training in special collections and resources such as health, self-check technology, and genealogy.
