

Library Programs of the Year

2012 Awards, Presented on May 20, 2013 by the Southern Adirondack Library System at its 55th Annual Meeting

Saratoga Springs Public Library for Sensory Story Time and The Sunday Club: "Sensory Story Time" and "The Sunday Club" are programs that form an important part of the library's overall array of programs and services for young people on the autism spectrum and their families. "Sensory Story Time" is geared to young children with sensory integration issues and those on the autism spectrum who might have trouble sitting through the other story times. "Sensory Story Times" are highly structured and interactive and make use of multiple senses. "The Sunday Club" is an informal information club for teens on the autism spectrum, who get together to play board games and socialize. These two programs complement parenting programs offered by the library for parents and caregivers of young children with autism spectrum disorders.

Town of Ballston Community Library for *Home Delivery Book Program*: The Town of Ballston Community Library, in partnership with the Saratoga County Office for Aging and the Town of Ballston, offers a home delivery book program. When a patron expresses interest in the program, the patron is contacted, and a bag of books is delivered to Town Hall. Through the Saratoga County Home Delivery Meals Programs, homebound people residing in Ballston and Charlton receive books with their meals. Library staff bring the books weekly to Town Hall and pick up the books already read. Recent studies found that reading fiction gives people the same sense of well-being and belonging that they get from actually socializing. By providing books to the homebound The Town of Ballston Community Library helps to fill this very important need.

TAKING STOCK: Minimum Standards

Regulations of the Commissioner of Education

Regulation 90.2: Standards for Registration of Public, Free Association and Indian Libraries

- (a) A public, free association or Indian library will be registered if it meets the following standards satisfactory to the commissioner:
- (1) is governed by written bylaws which outline the responsibilities and procedures of the library board of trustees;
- (2) has a board-approved, written long-range plan of service;
- (3) presents an annual report to the community on the library's progress in meeting its goals and objectives;
- (4) has board-approved written policies for the operation of the library;
- (5) presents annually to appropriate funding agencies a written budget which would enable the library to meet or exceed these standards and to carry out its long-range plan of service;
- (6) periodically evaluates the effectiveness of the library's collection and services in meeting community needs;
- (7) is open the following scheduled hours (see chart)
- (8) maintains a facility to meet community needs, including adequate space, lighting, shelving, seating, and restroom;
- (9) has a telephone, photocopier, microcomputer, printer, telefacsimile machine and other equipment necessary to facilitate access to information;
- (10) distributes printed information listing the library's hours open, borrowing rules, services, location and phone number.
- (11) employs a paid director in accordance with the provisions of Section 90.8 of this Part (see chart)
- (b) Any public, free association or Indian library registered by the department at the time this section takes effect shall be required to meet the standards for registration in subdivision (a) of this section on the following schedule:
- (1) meet the standards of paragraphs (1) through (5) and (10) of subdivision (a) of this section on or before January 1, 1995.

- (2) meet the standards of paragraph (6) of subdivision (a) of this section on or before January 1, 1997.
- (3) meet the standards of paragraphs (7), (8), (9) and (11) of subdivision (a) of this section on or before January 1, 1999.
- (c) Variances. If circumstances over which any public, free association or Indian library has no control prevent it from meeting one or more of the standards of service set forward in subdivision (a) of this section, such library may apply for a variance for such standard(s). The application for such variance shall be submitted for such library by the public library system of which such library is a member, in a form prescribed by the commissioner. No variance granted pursuant to this subdivision shall be deemed to relieve a public, free association or Indian library of any obligation imposed by any other provision of federal or state law.





Federal Library Services and Technology Act (LSTA) Grants (FY2012-2013)

New York Library Trustees Online (NYLTO) (\$11,400 in 2012) A public library trustee provides leadership to advance the best interests of the library he/she serves. In order to do so, a trustee must continuously improve his/her knowledge base, skills and expertise in library matters. Making and approving policies for the library is one of the most important roles of a public library trustee. The Southern Adirondack Library System (SALS), in partnership with the Clinton-Essex-Franklin (CEF), Mid-York (MYLS), Monroe County, North Country, Ramapo Catskill (RCLS), Southern Tier (STLS) library systems and the Onondaga County Public Library worked with E-Learn Libraries to develop an online trustee orientation and development center with content geared to public library trustees, public library system staff, and member library managers. A total of 700 directors and trustees enrolled state-wide.

Summer Reading Program (\$12,000 in 2012)



- The Library resources and events provides me with inspiration and insights to help guide my professional and personal goals.

- We use the library on a weekly basis...whoever says that libraries are dying out should visit Crandall Library what a wonderful asset to the area!!!
- I'm thankful we have such a wonderful library close to our home. We enjoy the tranquil space as well as exploring new reading material. We also appreciate the various children programs that you offer during school breaks and in the summer. Thanks a Million!!
- You are keeping our minds & souls alive- expanding intellect & if you close down- the world will close with you.

These responses reflect that we utilize our state resources effectively; infusion of CLDA funds enhances staffing for CBA collection development and interlibrary loan. Lastly, within our Central Library Plan of Service the CBA materials objective states, "To purchase materials in all formats to allow the central library to function as a major information, resource sharing provider in years 2012–2016." We meet this objective.

About Libraries Today

- 58% of adults in the U.S. have public library cards. 61% of the population in the SALS service area are public library card holders.
- The 2011-2012 ALA *Libraries Connect Communities* study reported that 76.3% of libraries reported offering e-books, an increase of 9% from 2010-2011. For libraries in the SALS service area, this service increased 88%.
- Americans check out an average of more than eight books a year. They spend \$35.81 a
 year for the public library about the average cost of one hardcover book. SALS
 member library patrons checked out an average of twelve books in 2012, and spent
 \$50.20 for the public library.
- Almost 89% of public library outlets now offer wireless internet access. 100% of the libraries in SALS offer wireless internet access.
- Americans go to school, public and academic libraries more than three times more often than they go to the movies. There were 2,458,651 visits made to SALS member libraries in 2012.
- Americans spend nearly three times as much on candy as they do on public libraries.

During 2012, we fulfilled our mission to improve and expand library services through the dedicated work of the Board of Trustees, SALS staff and our Central Library, Crandall Public Library in Glens Falls.
