networking, people who know about, um, all kinds of things, and, um, it just works out.

Delivery was the second most popular service, and that's, again, on, we've worked very, very hard.

So this collection is governed by a collection development policy, we also have a policy for book challenges and a forum for that.

And all of that information is located right on the ...

Website under policies.

So part of the selection process is that we have a suction develop or a selection committee for overdrive and that is made up of staff from the member libraries, both big and small.

And the way we facilitate that is each month, one person selects titles to add to the shared collection.

24:41 - 24:48

[speaker unknown]

So they create a cart, and throughout that month, I go into that cart, and I pull stuff out to order.

So we're adding new titles every week, Plus, I'm also purchasing extra copies of popular titles with holds, lots of holds on them to keep, to add to the collection.

And the way the collection is funded is Crandell Public Library pays the annual Overdrive platform fee using the Central Library Aid funds that they receive.

Sayles also applies for a grant from Saratoga County on behalf of the Saratoga Libraries in the amount of \$35,000 to purchase Overdrive, e-books, and audiobooks, so that's a big chunk of our funding for the collection.

Um, and in addition to that, all of them, sales member libraries contribute 3% of their previous years.

25:43 - 25:52

[speaker unknown]

Overall materials budget up to a cap of \$5000, so the larger libraries are contributing \$5000.

And libraries are always welcome to contribute more.

They just need to contact us.

And let us know, and we will help them do that.

Um, the average cost of an e-book for libraries is about \$34.

The average cost of an audio book is quite a bit more.

That's at \$68.

We currently have 12,518 titles in our overdrive collection.

So it's really grown tremendously over the years at a lot right along with the usage.

And due to the popularity of this collection, I try to maintain a 15 to 1 hold ratio.
