Paul-

On June 26, 2024, we performed a series of (6) - 4" Diameter cores through the existing pavement and underlying subbase, at the above referenced location. There were sections of the lot that showed three courses of pavement (Binder and two separate top courses), and sections of the lot that only show two courses of pavement (Binder and top course). Average thickness of the three-course pavement was approximately (5.8") respectively. Average thickness of two course pavement was (3.5") respectively. In all location however, there was little evidence of consistent subbase and what was there, was comprised of silty gravel to in some cases, common fill type soil.

Based upon these findings, it is recommended to remove all existing pavement, and subbase/subsoils to an overall depth of 12" from existing pavement grade. Proof roll the subgrade to verify its basic structural integrity and refine the grade to provide positive pitch and related drainage. Install a layer of Mirafi 500X soil stabilization fabric and import and install (8") of NYS Approved Type 2 Crushed stone subbase. Fine grade and compact in preparation for pavement. Install a two-course pavement system consisting of 2.5" of NYS approved Type 3 Binder and 1.5" of NYS approved Type 6 top.

The reconstruction of this lot as proposed above should provide a quality lasting product that should be able to yield a useful life expectancy of 14-18 years.


