## Q2

What are the goals and objectives of your project?

Based on our Strategic Planning goal of sustainability and making environmentally-sound facility decisions, our Library would like to install an Electric Vehicle (EV) Charging Station in our parking lot for public use. The station would potentially attract new library users and people from out of town to our location. It would also help to encourage electric vehicle usage, decreasing environmental strain. With this SALS Challenge grant, we hope to offset some of the costs of the installation. The overall cost of the 1- dual port EV station would be \$17,465.75. Livingston Energy Group, who provided the quote, would then apply for a utility grant on our behalf, eliminating approximately \$10,800 from the costs. The remaining \$6,665.75 would be the responsibility of the Library. It is for this Library portion, that we are applying for a SALS Construction Challenge Grant. Livingston Energy's quote includes full installation, the hardware, 5 years of software and networking, and 5 years of full maintenance on the whole system. The station would be set up to charge users a minimal fee for use, so the Library would not have additional costs associated with the new service.

## Q3

How will this project change the library building?

The project will not change the library building itself, but will add a new outdoor service. The charging port would be located approximately in the middle of our row of parking spaces and would be positioned to allow several nearby parking spots to reach it. This location is in keeping with the Library's long-range building goals. The station's position would allow usage of the Library's wireless internet service as well, for those waiting for their vehicle to charge.

## Q4

How will this project benefit your patrons?

Patrons will have access to a low-cost EV charging station in an area that does not have many options for this service. For patrons who have electric vehicles, this installation will make their library trips more convenient. For non-patrons, this service will introduce new people to our facility and potentially create new library users. This addition would also benefit the community at large by allowing more consumers and visitors to come to our downtown area and discover all that Schuylerville has to offer, allowing our Library to assist in economic development.

What is the timeline for the project?

We anticipate beginning this project by mid to late February 2024, once we submit our grant application to SALS for consideration. Installation has been estimated by the contractors to take only three days, with minimal interruption to library operations.
